He then said that the equipment available for use for N.C.P.F. competitions – laptops, projector and scoring machine are not fit for purpose and he proposed that the N.C.P.F. should look at purchasing replacements. Jane asked which scoring machine was being used as there is another better set. This will be looked at. John also suggested that ALL equipment should be available for use by each subcommittee as and when required. After a heated discussion regarding the use of the new laptop it was agreed that an external hard drive should be purchased for storing the International Salon images, which would free up the laptop for use by the Competitions subcommittee when required. Gerry Adcock then pointed out that when judging the Annuals, more than one laptop is required. The subcommittee had to use their personal laptops at the event that had just taken place in April. Cliff Banks had also produced a report listing all of the equipment held by the Federation with suggestions for it to be

replaced/disposed of. In view of this report, and the fact that we still do not have an Archivist, it was suggested that Cliff be approached to see if he would agree to take on this post. Further discussion took place regarding the repair or replacement of the Canon projector. Gerald Chamberlain said that he had just looked into this for his club and had now purchased one. He agreed to send this information to the secretary who will then speak to Cliff regarding the role of Archivist and the purchase of new equipment. Trevor Walters asked when the dates for next year's competitions would be available. John said that this will be discussed at the next subcommittee meeting. Report attached and accepted.

Dear Federation Secretary,

I have been investigating the possibility of posting out the next PAGB Handbook directly to recipients. I realise that some Federations distribute the handbooks by handing them out at meetings and other events while other Federations post them out to recipients using Royal Mail.

The current handbook would cost £1.64 to post out using second class postage with Royal Mail. I have received a quote from a specialised mailing company who would charge 88p to mail out each handbook to recipients, this quote being based on mailing out 1,000 copies of the handbook and includes the addressing and filling of envelopes.

Could you please let me know if your Federation would like to take advantage of such a service to distribute the handbook to your clubs, lecturers and judges. If you decided to distribute the handbook in this manner all I would require from you would be the database of names and addresses of the recipients and I would handle everything else.

Obviously, I would need a sufficient number of Federations to utilise this service to make it viable.

The Northern AV Group Events and GDPR - 23 April 2018

Hello, I am emailing you to ask your opinion about contacting the Secretaries of other NCPF clubs when we wish to advertise our twice yearly events.

Because we have a variable membership and after extensive research and reading of documentation about GDPR plus a phone call to ICO to confirm our suspicions we have produced an Opt-in form for our members and supporters. This has been circulated to every individual on our mailing list so that when we advertise our next event in Autumn we know that we have complied with the new regulations when we contact people who have attended our meetings in the past and who, in response to our form, have opted in.

However, in the past we have also sent out our advertising flyer to all the clubs in the NCPF group.

According to ICO we are therefore "marketing" and as the secretaries of each club can be termed "individuals" we would need to seek their consent.. Now we do not want to create a storm within NCPF by suddenly circulating all the secretaries to ask them to opt in to receiving our information but we would like to know where you think we stand in this and what our course of action ought to be.

I have checked the PAGB guidance of April 2018 and it would seem the section about Electronic Marketing is the part relevant to us, (in italics below to save the need to go and find it.):

What specifically I would like to know is this. Our custom and practice was to send to all clubs a copy of our advertising flyer which included the form needed to attend..I would suspect that would be tantamount to asking secretaries to cascade marketing material by electronic means. If, instead, I make a poster, advertising the event and advising where attendance forms can be obtained by anyone who wanted one, would that solve the potential problem?

Electronic Marketing

The Privacy and Electronic Communications (EC Directive) Regulations 2003 are separate from and additional to the data protection legislation. Essentially, the circulation of marketing material by electronic means is prohibited without express consent by the data subject, and a data subject is entitled to withdraw consent at any time. The definition of marketing material includes any offer of goods or services addressed to an individual. The Information Commissioner's Office has more detailed guidance. Marketing material would not include information to members about a Club's normal activities. There is no prohibition on general advertising, or material not directed to an individual eg, a poster or a pile of leaflets at a Club meeting. **Action:** Unless Clubs are prepared to manage their own comprehensive consent process:

- · Clubs must not make their membership contact information available for electronic marketing.
- . Clubs must refuse any request to cascade marketing material to members by electronic messages.

a. Competition Chairman's Report May 02nd 2018

Annuals

The above competition took place as planned on the 6^{th} /7th April 2018, due to the reduced number of entry's we were able to complete the main competition on the Friday.

I contacted the judges for both the Alliance & Portfolio on the Friday regarding bringing the judging time forward which without exception all agreed. This allowed the judging to start at 10:00am rather than 1:00pm, considering we were planning as we went, everything worked reasonably well.

(This arrangement will be discussed at the next sub-committee meeting)

The Full Results were published on the website on the 13th April 2018.

Issues Arising which need to be resolved

- 1. The laptops which were available would not boot up and are basically not fit for purpose. In order to run the PDI Competition we had to borrow our own personal laptops which were designated for the print Competition.
- 2. The one Scoring machine we had was faulty had kept giving problems which just adds to the frustration of running the competitions.

The problem we had experienced at the Club Championship regarding the level of light was mostly overcome by temporary blanking out of two of the main windows and we were assured that a more permanent solution would be found for the future events.

Presentation

A date for the presentation in November will need to be agreed.

Sub Committee

A sub-committee meeting is to be arranged in the near future to discuss issues arising from both the Club & Annuals competitions. A report will be produced for discussion at a future Executive Meeting.

b. NCPF Equipment

Hi Margaret,

I realise that I no longer need to give reports to the exec but wish to bring the following to their attention.

State of the IT equipment

1. We have a number of scoring systems

They need to be checked out as at least 2 sets have occasionally sticking Keys.

One set bought for use with the Wade Clutton software only shows on a pc and does not integrate with the spreadsheet. **Dispose of.**

- 2. We have a set of lights for use with the pc's. They were dropped by one of the Annuals team and need to be checked out, may need some spare bulbs.
- 3. We have a black laptop well passed its sell by date. This should be disposed of.

The Ferrari laptop runs off XP and will not accept XL spreadsheets. **Either re format and install windows 10 or dispose of.**

The latest machine is held by Joe Grabham.

4. The original projector is only 1024 x 768 pixels and should be disposed of.

The current projector is showing slight fringing, which may be the bulb approaching the end of its life. Suggest this Projector (now obsolete by cannon) is refurbished professionally.

Any equipment being disposed of should be offered to the clubs (Sunderland PA would be interested in the original projector as it is the same model they have)

We do not have a standby projector which could be a major problem during judging. Suggest we buy a new one. Unfortunately the Cannon Xeed as used by PAGB is close to £3000.

International Salon Report 02nd May 2018

The committee met yesterday to review all the arrangements so far. Each member now has an information sheet which lists the judges, the timetable for the judging, the Exhibition calendar and the dates of when and where two of the judges, Paul Keene and Paul Stanley are giving a presentation of their work.

The date of opening for entries was discussed and 1st July was chosen.

Cliff's review of equipment, which is on this agenda was discussed.

Preparation for the opening of the 39th Salon will be done on Sunday 24th June.

As the salon is later this year I hope there will be interest and entries from the clubs. There is the usual discount for club or member and if several clubs enter perhaps recognition for the best club or member.

REPORT OF THE REPRESENTATIVE TO THE PHOTOGRAPHIC ALLIANCE OF GREAT BRITAIN TO NCPF EXECUTIVE COMMITTEE 2nd May 2018

- 1. The Alliance AGM was held on Saturday 14th April and was followed by the normal Executive meeting on Sunday 15th. Gordon Jenkins was awarded the J.S. Lancaster Medal for longstanding service to the PAGB and photography in general.
- 2. The meeting was preceded by a presentation form Mark Baber of Sony on their products and their services to photographers. They are willing to present a full day workshop to interested Federations. If there is interest from NCPF I will forward the details to Clive Tanner of PAGB.
- 3. Agreement was reached that the Annual subscription, inclusive of PLI, will be increased to £38 with effect from January 2019. This small increase, very much in line with inflation, is to help cover some of the forecast budget deficit for 2019 which will be largely covered from reserves.
- 4. A further revision of the Data Protection Policy was agreed and I have modified a version for the NCPF which is attached at Appendix 1 for consideration. If this is adopted I recommend that a version be circulated to all clubs with basic guidance on what they need to do in order to meet the new requirements. This will include seeking the agreement of club members to be contacted electronically in future. The NCPF will also have to consider the implications regarding future electronic marketing. I have also included at Appendix 2 a data protection preamble and a draft policy suitable for an individual camera club for consideration.
- 5. Howard Tate should by now have contacted all Federations regarding the future circulation of the PAGB Handbook. A decision on this offer could assist the Federation.
- 6. The PAGB Print Archive is available to any Federation for possible workshops and presentations. I recommend that this Federation considers if any prints would be of use.
- 7. The next meeting of the Executive will be on the weekend of 6th and 7th October 2018 in London.

Appendix 1

Data Protection Policy

The Northern Counties Photographic Federation (The NCPF) is established with the objects set out in its Constitution, to serve the interests of its Affiliated Clubs. The NCPF is a data controller within the UK.

The personal information referred to in this Policy may include name, distinctions, contact details, affiliations, service records, records of entries to events, and such other information as may be necessary for the effective management of the legitimate interests of the NCPF. Any person wishing to verify the information held by the NCPF, or who can correct or update that information, may apply to the Secretary.

The NCPF collects and uses personal information for several purposes:

- 1. The NCPF Directory: a. The NCPF Directory includes contact information about the members of its Executive and those volunteering their services as judges or lecturers. The Directory also includes an archive record of the names of those awarded by the NCPF. b. The Directory is circulated to Affiliated Clubs, and to those whose contact details are included. c. The contact details of NCPF officials allocated to provide particular services may be published generally.
- 2. Northern Focus: a. Northern Focus contains editorial material and may include contact details of those submitting material for publication. b. Northern Focus is published on a web site and is viewable by anyone.
- 3. NCPF Events: a. Photographers, as the creators of images, enter NCPF events either directly or via their Club. b. This information is held and managed subject to the General Conditions for NCPF Competition Events.
- 4. General Business: a. The NCPF may hold personal information for anyone contacting the NCPF, or whom the NCPF contacts for the purpose of conducting its general business. b. This information is used to satisfy a requested service or a contractual requirement.

Data Retention

1. General business records will normally be held for a minimum of eight years. 2. The NCPF may retain historical archives indefinitely, for example but not limited to, records of meetings, directories, catalogues, awards and other event results.

Any person previously authorised to hold personal data on behalf of the NCPF, and who then ceases their connection with the NCPF such that they are no longer authorised, is required to take all reasonable steps to delete that personal data, whether on physical or electronic media. Where those reasonable steps have not deleted all personal data, then the NCPF grants permission for the retention of that residual personal data, provided that it is not used in any way.

EU General Data Protection Regulation (GDPR)

Morton Photographic Society (MPS) is what's known as the 'controller' of the personal data you provide to us. We will usually collect basic personal data about you like your name, postal address, telephone number and email address.

Why we need it

We collect your personal data in connection with specific activities, such as registration or membership requests, competition entries, and events organised by MPS.

We only collect your personal information when you provide it to us directly.

We will also hold information about your details so that we can respect your preferences for being contacted by us.

We will only disclose information to third parties or individuals when obliged to by law and in the following situations:

- If you have agreed that we may do so.
- If we submit your images to other named photographic organisations and clubs your details may need to be shared.

We will never sell or rent your personal information to other organisations.

We hold your information only as long as necessary for each purpose we use it.

If you decide not to support MPS any more or request that we have no further contact with you, we will keep some basic information in order to avoid sending you unwanted materials in the future and to ensure that we don't accidentally duplicate information.

What are your rights?

A new data protection law, starting in May 2018, gives everyone a number of very important rights. These are:

- Transparency over how we use your personal information (right to be informed).
- Request a copy of the information we hold about you, which will be provided to you within one month (right of access).
- Update or amend the information we hold about you if it is wrong (right of rectification).
- Ask us to stop using your information (right to restrict processing).
- Ask us to remove your personal information from our records (right to be 'forgotten').
- Object to the processing of your information for marketing purposes (right to object).
- Obtain and reuse your personal data for your own purposes (right to data portability).
- Not be subject to a decision when it is based on automated processing (automated decision making and profiling).

If you would like to know more about your rights under the data protection law see the Information Commissioners Office <u>website</u>.

Remember, you can change the way you hear from us or withdraw your permission for us to hold your personal data at any time by contacting the Secretary.

Morton Photographic Society (MPS) is established with the objects set out in its constitution and is a data controller within the UK.

The personal information referred to in this Policy may include name, distinctions, contact details, affiliations, service records, records of entries to events, and such other information as may be necessary for the effective management of the legitimate interests of the MPS. Any person wishing to verify the information held by the MPS, or who can correct or update that information, may apply to the Secretary.

MPS collects and uses personal information for several purposes:

- 1. The executive committees of itself and of its members; others who assist those executive committees; and those offering their services to the MPS community eg, as judges or lecturers. This information is used to facilitate administration and services. The contact details of MPS officials allocated to provide particular services may be published generally.
- 2. Morton Photographic Society website and Facebook presence:

 The website, https://www.mortoncarlisle.photography/, and the MPS Facebook page contain editorial material and may include names of those submitting material for publication. Both sites are accessible to the public and are viewable by anyone.
- 3. Others necessary for the conduct of the business of MPS. This information is used to satisfy a requested service or a contractual requirement, and may be retained to confirm the outcome.
- 4. Photographers as the creators of Images used in the activities of the MPS. This information is managed subject to the General Conditions for MPS Competition Events.

Data Retention

- 1. General business records will normally be held for a minimum of eight years.
- 2. MPS may retain historical archives indefinitely, for example but not limited to, photographic images, records of meetings, awards and other event results.
