Margaret said that the people who could answer this question were not at the meeting but she was sure that this was part of the protocol in the Judge's Handbook. This will also be raised at the judge's subcommittee meeting.

Jane said that she has recently had an influx of requests for information from club members regarding the application for PAGB accreditations. She asked if this information could be more prominent on the NCPF website as a stamped addressed envelope is required by all applicants to allow her to post off the relevant documentation. Margaret said that if she gets any further requests she will pass this information on.

Margaret said that she had been in contact with Cliff Banks regarding the role of Archivist and as long as he doesn't have to store anything at his home he is quite happy to take on this role. A formal acceptance was proposed by Dave Coates and seconded by Jane Black.

Jane raised the question of premises to run the Salon when Tynemouth PS move out of the Library. She said that to run the Salon they need somewhere that can be set up with the equipment and left in situ for at least four days. The only club with its own premises is Cambois. This will also depend on availability.

Margaret then said that she had been looking at storage facilities for the Archive Equipment and this is not an option as the cost would be too much – approximately £100.00 per month for the smallest unit. Richard Speirs suggested asking Woodhorn if they would store our prints. This would not cover storage of the other equipment which needs to accessible when needed. This needs to be looked at by everyone urgently.

Margaret then read out correspondence received from Cliff regarding the refurbishment and purchase of projectors and laptops. After a long discussion it was agreed that Cliff should be authorised to purchase a new projector and laptop as suggested by Gerald Chamberlin as well as a new external hard drive. It was also suggested that he purchase two good quality HDMI cables. The reformatting of the Ferrari laptop was also approved. This was carried unanimously by a show of hands.

Peter raised the question of a scoring machine. Jane said that she had another machine she had been given by the RPS.
