The 40th NCPF Salon began well with 305 increase in entries led by England and supported by China, Scotland, Hong Kong and Germany all showing a three figure entry total.

We were pleased to welcome back previous judge Lip Tan Seng from Singapore to judge colour, Monochrome and Travel together with Peter Gennard from England judging all sections. Also from England we were pleased to welcome for the first time Ian Whiston to judge Nature. Representing NCPF Leo Palmer was judging Monochrome and Travel, Dave Coates Colour and John Webster Nature.

We were pleased to be once again judging in Tynemouth club rooms now moved to North Shields and we sincerely thank Tynemouth for their major effort to get their new club rooms ready in time.

On the first day judging of the Nature section went smoothly and the only problem was the firm bringing the lunch forgot and lunch was delayed until 1.30/2.00. Little did we know that this was just the beginning of many problems. The next day the software crashed and the judging had to be extended to Saturday. The result was a massive amount of work was created and the members of the team had to work hard to meet our deadlines. Over the following weeks, led by Dave, the team of David (Brown) Joe and Alan worked constantly to sort out the problems and save the Salon.

In forty years there had never been such a crises. Dave worked ceaselessly with the team of three supported him all the way, determined to save the Salon and they did. They derserve Medals.!

REPORT OF THE REPRESENTATIVE TO THE PHOTOGRAPHIC ALLIANCE OF GREAT BRITAIN TO NCPF EXECUTIVE COMMITTEE 5th November 2019

- 1. I attended the PAGB Executive meetings held on the 5th and 6th of October in London. The following are the main points of relevance for the NCPF.
- Concern was expressed that a number of lecturers and judges in the PAGB Handbook and in Federation Directories were charging clubs more than PAGB agreed expenses. Federations are recommended to remind their judges and lecturers that they should abide within charging limits set by the PAGB unless they have come to a prior agreement of a higher fee from a club booking their services.
- 3. I had a meeting with the PAGB's insurance brokers in London before the Executive Meeting on Friday 4th October. They confirmed that the system for collecting Insurance Premiums from Federation Clubs will have to alter as a consequence of legal changes which prohibit third parties from collecting and holding Insurance Premiums on behalf of other people and organisations. This means that clubs will have to make their Insurance payments directly to the PAGB Brokers. In association with Darwin Clayton and members of the PAGB Executive I have produced a draft letter to go to all clubs explaining the change and what clubs must do when their current policies expire in January 2020. The draft letter is attached to this report and can be modified to suit each Federation. At the time of writing this report the draft is out for approval from members of the PAGB Executive.
- 4. Rules for PAGB Competitions are currently under review to address breaches of rules and procedures for effectively handling them. Following a number of requests a draft Constitution for Camera Clubs is being developed as it has become apparent that a number of existing ones may be ineffective or illegal in the terms they use
- 5. The structure for PAGB Competitions is also under review with proposals to modify and simplify entries for the Inter Federation Print and PDI contests and the GB Cup and Trophy. It is proposed to adopt the position that for Nature images "if it looks like nature it is nature." This it is hoped will resolve the use of nature entries in open categories in competitions.
- 6. Concern was widely expressed at photographers recycling pictures in competitions by joining new or additional clubs to allow their pictures to continue to be used in PAGB competitions. It is proposed that "once an image has been entered into a PAGB club competition it can never be entered into any other PAGB club competition by a different entrant".
- 7. It was also proposed that the following modification be made to rules for PAGB Competitions. "Only one entry is allowed from an author who lives more than 30 miles outside the geographic limit of the club's Federation" This was proposed to exercise some control over clubs who use external authors from all over the country to produce their entries.
- 8. There is also a proposal to change the rules regarding the use of similar images in competitions. The draft wording under consideration is "Where the principal element of a picture is so similar as to be nearly identical to another image". This has come about following concern that virtually identical images being repeatedly entered into competitions by a number of photographers. The exact wording has yet to be finalised.
- 9. Sunday morning was largely devoted to discussing what can be done to encourage the production of prints at local and national level. There was a general perception that camera clubs are deserting printed images in favour of projected images. Several of the delegates identified that in their Federations the opposite was the case. In order to quantify the national position each delegate was asked to report on the situation in their Federation by circulating their clubs on the question.
- 10. The next meeting of the PAGB will be on 1st and 2nd February 2020 followed by the AGM on Saturday 4th April 2020 after which there will be an Executive meeting on Sunday 5th. Barring any unforeseen circumstances I will be attending on behalf of the NCPF. As mentioned previously to this Executive, the April 2020 AGM will be my last meeting of the PAGB Executive. I have indicated that I am prepared to continue as the Insurance Officer until the publication of the next PAGB Handbook in order to simplify any queries from clubs during that period. I would recommend that this Executive authorizes my replacement as NCPF Representative to accompany me to the AGM to introduce them to the PAGB Executive.

Insurance for Clubs

This information requires urgent attention by your Club and Committee

The Photographic Alliance of Great Britain advises that all clubs should hold Public Liability Insurance. This protection means visitors and the general public at events and shoots can claim for injury or property damage. Such claims can be very expensive and cover for £5 million is usual.

Nearly all clubs have used the policy negotiated by the Photographic Alliance (PAGB) with the broker Darwin Clayton. Each year Darwin Clayton has provided a schedule of premiums which is cascaded down to clubs, with each premium collected alongside the club's subscription to the (Your Federation). (Your Federation Acronym) then remits the total to Darwin Clayton who issues the cover certificates. (Your Federation Acronym) accounts show the premiums collected, with the same amount remitted.

Over the summer, the PAGB has been in urgent discussions with Darwin Clayton because of changes that prohibit an unregulated intermediary acting between the insured e.g. a Club, and a regulated provider of insurance. The PAGB has been considering the consequence of this change.

Choice of Provider

The PAGB will continue working with Darwin Clayton to ensure that policies suitable for Clubs are available. The PAGB will periodically undertake market research aimed at ensuring the chosen provider is able to supply clubs with suitable insurance solutions. Clubs can continue to use Darwin Clayton if they wish or can choose any other insurer.

Payment of Premiums

(Your Federation Acronym) will send the schedule of Public Liabilities from Darwin Clayton as before, however it will not collect the premiums and request that Clubs contact Darwin Clayton direct. Darwin Clayton will provide advice on other insurances that are available including but not limited to "All Risks and Management Liability". Although clubs may arrange cover with Darwin Clayton immediately, the documentation will be issued in the New Year before renewal on 31st January 2020.

Timing

Clubs should each have a copy of their current cover certificate, and that public liability insurance ceases at midnight on 31st January 2020. Clubs must have decided on their preferred insurer and have made arrangements for cover and premium payment by that date.

Verification

Because of the importance of public liability insurance in protecting judges and lecturers listed by (Federation Acronym) each club will need to provide verification of its insurance status. Darwin Clayton will furnish a list of Clubs who have arranged insurance with them to each Federation after 1st February.
