Competition Sub-Committee Report - 07th November 2022

A sub committee meeting was held on 17th October to review arrangements for the Presentation Awards on Sunday 20th November. All tasks have been allocated and are being actioned. The Awards script was signed off and a draft pdi/powerpoint presentation of awards images to compliment the script has been produced. (NB We also need to confirm that the other pdi/powerpoint presentation stemming from the 2022 Annuals - the Portfolio has been produced. This was due to be sent to Carlisle CC prior to 25th October.)

Following the sub committee meeting I contacted Clara Vale on 27th October to re-confirm our booking for the Presentation event on Sunday 20th November and was told that they did not have a record of our booking. I forwarded copies of the emails making the booking and their acknowledgement by Clara Vale. After checking, they confirmed they did have the booking and confirmation emails but had no record on their electronic booking system "HallMaster". After investigation they advised that at the time of the booking a paper system was in operation and the entries from this were later transferred to the electronic HallMaster system. However, although they had acknowledged our booking, it seems it had not been entered onto the paper system and was therefore not entered on the electronic system. The 20th November was no longer available as the hall had subsequently been booked and paid for by another party. Despite representations Clara Vale would not reinstate our booking. I was offered two alternative dates, the first at the beginning of November which I deemed too soon to complete preparations, and a second for Saturday 26th November which I took. There were no other dates available for the remainder of this year. As a gesture of goodwill, Clara Vale agreed to waive the charges for the hall. They confirmed our other bookings for 2023 were in their records. A notice was forwarded to all club secretaries with details of the amended date and a request to let members know, and the change was shown on the NCPF website. Thanks to Gerry Adcock for his prompt forwarding of the note and change to the website.

In the PAGB Inter-Club Print Competition, the NCPF was represented by Northallerton CC and Gosforth CC. The round 1 scores ranged from 118 points to 158 points and Northallerton scored 137 points and Gosforth scored 131 points. In the Plate, scores ranged from 82 points to 100 points and Northallerton were joint third with 97 points and Gosforth scored 84 points. Well done to both clubs for earning participating in this event and congratulations to Northallerton CC on their joint 3rd position in the Plate.

Web-Masters Report November 2022

The web site in its current guise will have been operational since 2015. Happily, there have been few operational difficulties to report.

The web site has been hosted by a company called Just Host since inception and they have been very reliable. The hosting was last renewed in November 2019 for 36 months at a cost of £246.83 and is now due for renewal.

Renewal with the present supplier was quoted at £582.16 for a 36 month term, as you can see a massive increase on the last renewal 3yrs ago.

Following consultation with the Treasurer Peter Yearnshire it was agreed that I should attempt to negotiate the price down with the present supplier, and if unable to agree suitable terms investigate changing supplier.

Early research into the market suggest that substantial savings can be found with other hosting company's, however this carries the risk that the web-site may not migrate successfully & migration will cause a disruption in service although if all goes well it should only be 24-48 hrs in duration whilst the new site propagates.

I will need to expedite this as a matter of urgency, but will of course advise the Executive re the final outcome.
