Margaret said that she had received an email referring to an APM Workshop for PAGB Awards and asked Richard Speirs to explain further. He explained that the PAGB had done a test run in association with the RPS and it was a comparison of the accredited awards given by both bodies. The idea was to offer a similar presentation to the Federations showing a selection of images with critique from Rod Wheelans, Libby Smith and Gordon Jenkins to give club members an idea of the level of photography required to qualify for an accreditation. The idea would be for a Federation to host the event for all of their clubs. Gerald Chamberlin explained that since he has taken over as PAGB Awards Officer he has found that club members are not aware that they can enter the adjudications and he proposed that we should take up the offer and promote it to the clubs. After discussion it was agreed that Richard Speirs and Gerald Chamberlin would pursue this further. Alan Wilson added that he would like to put an article in the NF regarding the lack of communication to club members by secretaries and he would expand his mailing list accordingly.

Annuals Competition 2021

This amendment resulted in Gosforth CC being declared the outright winner with Keswick & Saltburn Sharing 2nd place.

Alliance Entry

We will discuss and resolve the problem by changing the Rules at the next Competition Sub-Committee, but we must remember that we can change the rules but we will always have to rely on the clubs being honest and self-policing.

The Photographic Alliance of Great Britain Strategy Subcommittee On-Line Judges and Lecturers Register A Proposal – May 2021

Introduction

The PAGB Handbook's content can be broadly classified into:

- Confidential contact details
- Non-confidential information and the adverts
- Judges list
- Lecturers list

The Executive has agreed to publish a printed Handbook in the usual format later this year, while also undertaking a review of options for the future.

The Strategy Sub-Committee (SSC) has discussed the provision of a PAGB managed online register for speakers, meaning both judges and lecturers. The SSC has not discussed the other content of the Handbook, and that is not part of this proposal.

The SSC is now documenting its proposal for discussion and, most importantly, to facilitate testing by Federations before a decision is made on whether to proceed with development.

The SSC has adopted some important principles which run throughout this proposal.

- Federations will retain complete control over who they accredit as a judge or as a lecturer.
- Speakers will be responsible for managing and updating all their own contact details. Lecturers will be responsible for creating and managing all their own talk information.
- The register will only be viewable by either a Federation or an affiliated Club after secure logon via an authorised account in the Central Entries System (CES).

Summary

The proposal sets out a design for an on-line register of speakers (judges and lecturers) intended to replace the equivalent information in the PAGB Handbook.

The proposal shows available functionality based on a model of the data which seems to be relevant.

Federations are asked to 'desk-check' this design for completeness and accuracy. While any new system is not necessarily intended to replicate existing procedures, it is important to show that it is compatible with the various processes within all Federations.

NCPF North Tyne Area held its AGM via Zoom on Friday 19th February. The highlight of the meeting was to congratulate the group's treasurer Howard Wilson ARPS APAGB on his receipt from NCPF of a Meritorious Service Award with his name added to the Roll of Honour. It was also noted that 2 of our clubs, Gosforth CC and Whitley Bay PS, having achieved 1st and 2nd places in the most recently-held NCPF Club Championships (Prints) (January 2020) were eligible to compete at the PAGB InterClub Championship (Prints) if held in 2021. Gosforth CC also having come 2nd in the NCPF Club Championships (PDI) in January 2021 was eligible to compete in the PAGB InterClub PDI championships: both those events were at that time under consideration by PAGB, but have since been confirmed at least as 'virtual' competitions.

The North Tyne Area Annual Interclub PDI Competition 2021 was hosted by Tynemouth Photographic Society, and was held 'virtually' (via Zoom) on 22nd March. The judge was Alan Walker ARPS, MPAGB, MPSA, EFIAP, of Keswick PS; and all 6 clubs participated. The Event Trophy was won by Gosforth CC; and the trophy for best image in the competition (achieving the full 30 points) went to Richard Narcross of Whitley Bay PS for his monochrome portrait 'Hagged'.
