Margaret read out Gerald's report.

A meaningful discussion took place regarding the points raised in Gerald's report with respect to the expenses of the winning clubs who represent the N.C.P.F. at the P.A.G.B. Championships. Two proposals were agreed in principle. A) Clubs would pay an entry fee of £5.00 to take part in the competitions and B) All winning clubs would be given £100.00 each to subsidise their expenses when representing the N.C.P.F. in the competitions. In the absence of the Treasurer it was agreed that this would be discussed further at the next Executive Meeting when a final decision will be made.

20/02/08 Any Other Business

A.G.M. – A Special General Meeting will be held before the A.G.M. to amend Paragraph 6 of the Constitution relating to the disbanding of sub-committees at an A.G.M. Dave Coates explained the reasoning behind this change. Events are organised and take place between the A.G.M. in March and the first Executive meeting in May, effectively without an authorised sub-committee. After a short discussion, this was proposed by Dave Coates and seconded by Mike Allport and agreed by those present.

Subject: Club information on the Entries system

Dear All,

As discussed today, it would be really helpful if the Entries system had a complete list of (affiliated) clubs, which is verified by each Federation. Only affiliated clubs and their members can access PAGB services. A verified list will facilitate administrative actions to add individual user accounts.

The procedure to update a Federation's list of clubs is that an approved Federation user must use the Federation logon. Generally Federations have user accounts for Secretary, Executive member(s) and InterFed Officer. Logon is via email and password.

Click on Add or Edit Clubs. This shows your current list of clubs. Clubs cannot be deleted because they may have associated historical event data, but a club can be made inactive. Inactive clubs are greyed out. Compare the displayed list with your current Federation handbook.

Repeat for any missing club:

click + at the top to add the club

enter club name in full eg, Somewhere Camera Club

optional enter club meeting address

enter club meeting postcode

do not enter email as this is personal information done later when the

club registers a user

enter club website in full, starting http://

do not enter telephone as this is personal information done later when the

club registers a user

click on Active so that it shows a tick

click on Add Club

close using X at the top

Repeat for any club where the name needs correction (but it must still be the same club)

click on the club name in the list

edit the club name which must be in full eg, Somewhere Camera Club

close using X at the top

Repeat for any club in the list which has left the Federation or been dissolved click on the club name in the list untick the active box close using X at the top

Each club in the list can have a link icon if there is a website address and a map marker icon if there is a meeting postcode

Ideally, all active clubs in your list should have both icons

Repeat for any club with one or both icons missing

click on the club name in the list

enter the meeting postcode if required

enter the website address if required, in full starting http://

close using X at the top

The master list display does not update as you make edits. Just continue adding and editing until all done. You can refresh the list by closing (X at the top) and clicking again on Add or Edit Clubs.

Clubs which are active and have a postcode will appear on the Find A Club map which is publicity for the club.

Obviously this is a certain amount of work in the first instance. Lists should then be checked annually with each new Federation handbook, when the work is likely to be minimal.

North Tyne Area Report: 11th February 2020

A general meeting of North Tyne Area reps took place on Friday 1st November in Whitley Bay PS's club rooms. Sadly I have to report that one of our clubs, Wallsend PS, is experiencing severe difficulties involving loss of many members, resignation of several executives and needing to find alternative accommodation. They were scheduled to host the North Tyne Area Annual Prints Competition (see below), but were obliged to withdraw; and in September gave notice to the area Secretary (Peter Reynolds) that they would be unable to take part in future competitions until further notice. North Shields PS very kindly volunteered to host the competition at their premises with the day and judge as previously arranged by Wallsend. A new 6-clubs schedule for hosting North Tyne Area competitions was agreed.

Thus, the North Tyne Area Annual Prints Competition was held on Wednesday 27th November hosted by North Shields PS and judged by Jim Welsh LRPS CPAGB APAGB. Five clubs took part: in addition to the absence of Wallsend, apologies were received from Ponteland due to unavoidable extenuating circumstances. The Event Trophy was won by Tynemouth PS; and the trophy for best print in the competition (achieving the full 30 points) went to Colin Livingstone of Cramlington CC for his sports print *'Number 3'*.
