## 22/01/05 Treasurer's Report – Peter Yearnshire

Peter read through his report. He said that there had only been a couple of transactions since the last meeting. Margaret read out a letter Peter had received from Esh Winning. They are having problems accessing their business account as their second signatory, Bob Winter, has passed away. It was agreed by all that the PAGB/NCPF fees would be deferred until they are able to pay or wind up the club. Peter agreed to respond to the email. It came as a surprise to here that Bob Winter had died as the NCPF had not been notified. Dave Coates said that the best place to get any information would be the Pen & Methodist Camera Club. This will be looked into. Peter also informed everyone that Dumfries would not be joining the NCPF this year and the AV Group have also pulled out of the Federation. Peter proposed that when the Scottish Widows is due for renewal (either this year or next) it should be closed and transferred to the current account. This was approved and accepted. John read through his report. An email has been received from the PAGB informing the clubs that the Inter Federation Competition will be prints only this year. This will be forwarded to John after the meeting. In Gerry Adcock's absence John informed everyone that deadline for the Club Championships had now passed and that 18 clubs had entered the PDI section and 10 clubs had entered the print section. A subcommittee meeting is to be held on Monday 17<sup>th</sup> January 2022 to finalise the details. It was suggested that the low number of print entries may be attributed to the fact that some clubs are still not meeting in person due to the pandemic and therefore are unable to collect an entry.

David Brown said that the size of the PDI images required by the NCPF is still 1400 x 1050 which is not in line with the PAGB requirements of 1600 x 1200. He said that about 50% of clubs are now using the larger size and are required to downsize their images when entering the NCPF competitions. John said that this had been discussed at an earlier Executive Meeting and it was agreed that we should stay with 1400 x 1050 for the time being. This is being reviewed by the Sub Committee. He then queried the rule limiting the number of characters in a title to 25 as PAGB don't have a limit and International Salons state 35 to 40 characters. This is very restrictive especially for nature entries. He asked if this can be increased by at least another 10 characters. John said that this would be discussed at the next Sub Committee Meeting.

# NORTHERN AREA REPRESENTATIVE'S REPORT 12<sup>th</sup> January 2022

# **NORTHERN AREA KNOCKOUT COMPETITION**

The Northern Area Knockout Competition was held on Sunday 14<sup>th</sup> November 2021. This event was hosted by Blyth Photographic Society and the three judges were Gerry Adcock ARPS, Joseph Duffy LRPS, CPAGB, APAGB, and Peter Maguire LRPS, CPAGB, EFIAP.

After Round 1 Blyth, Amble, Cambois and Morpeth competed for the Trophy. The two clubs who made it to the final were Blyth and Amble with Amble winning with 189 points to Blyth's 180.

Ashington and Wooler, who were the two lowest scoring clubs from round 1, competed for the Plate and this was won by Ashington with 166 points to Wooler's 165. Two images gained the highest score of 15 points and they were entitled 'Black Rock Cottage' by Graeme Pattinson and 'Hong Kong' by Mavis McCormick who are both from Amble PG.

Considering that this was the first Interclub Competition to be held since the lockdown in March 2020, it was very well attended by the clubs who took part. Wooler CC was welcomed back into taking part in the Northern Area Interclub Competitions. They have not competed for a few years and missed out by 1 point of winning the Plate. The respective clubs provided a very nice pooled tea and refreshments were supplied by the host club. Thanks to the members of Blyth and the three judges for an enjoyable afternoon.

## **NORTHERN AREA PRINT COMPETITION**

The next Northern Area Interclub Competition is the Colour & Monochrome Print Competition which is scheduled to be held on 27<sup>th</sup> January 2022. The host club is Ashington CC and David Hall will be judging. All entry deadlines and venue information were sent out by Ashington's Competition Secretary just before the Christmas break. Since then they have been informed by the Church that St. Aidan's Church Hall will not be reopening until the end of the season. After several phone calls and emails, this competition will now be held at St. Mary's Church Hall, Blyth.
