REPORT OF THE REPRESENTATIVE TO THE PHOTOGRAPHIC ALLIANCE OF GREAT BRITAIN TO NCPF EXECUTIVE COMMITTEE 13th January 2020

- 1. As members of this Executive will be aware changes to the renewal of Federation and Club insurances is still ongoing. For Public Liability cover this Federation and our clubs will have to either renew their policies directly through Darwin Clayton or with another suitable provider. Darwin Clayton are notifying all Federations of those clubs who previously held policies with them but have not renewed. This will enable Federations to contact those clubs concerned to verify if they have taken out a policy with another insurer or if they have just neglected to renew with Darwin Clayton. It is important that clubs are checked each year to ensure that club members, visitors and judges and lecturers are adequately covered against risk.
- 2. The process for taking out Management Liability cover has also changed. Previously the PAGB held a Policy for Trustee Liability which allowed basic cover for each Federation and Club. In the view of Insurers this system could not continue for the same reasons as clubs having to take out their own PLI cover. A full Management Liability cover for a club has a basic premium of just over £150 per year which may well be beyond the budget of most clubs. Our brokers recommend that the PAGB and all Federations should take out such cover however clubs should way up the cost against the fairly minimal risk of ever having to make a claim. Our brokers are not wholly convinced that the Insurance Companies are correct in their interpretation as regards Management Liability cover and are still in discussions in the hope of reverting to the previous arrangement.
- 3. The next meeting of the PAGB will be on 1st and 2nd February 2020 followed by the AGM on Saturday 4th April 2020 after which there will be an Executive meeting on Sunday 5th. Barring any unforeseen circumstances I will be attending on behalf of the NCPF.
