EVENTS SUB-COMMITTEE REPORT

From comments and emails received the NCPF Spectacular on the 26th January at the Newcastle Novotel was enjoyed by attendees who were entertained by speakers with two contrasting approaches to their photography.

Peter Gennards' PDI presentations were supported by equivalent prints displayed around the room. His style of photography primarily involved the creation of composite images where he set out to 'photographically collect' portraits and background components which he subsequently combined to achieve the final desired image.

The lectures given by Roger & Judith Parry were Print based were primarily created in the 'studio' or on 'location', involving mainly figure studies the end result had been pre-visualised the majority of the time.

The two contrasting approaches were striking and enjoyable.

Financially the event was not a success. Low attendance figure of 47, including speakers and helpers, plus a lower than expected contribution to costs by our sponsors – PermaJet (£155 instead of the expected £210) will lead to a shortfall likely to be in the region of £650.

My sincere thanks to the Events Sub-committee members who helped in the planning and the running of the event; Cliff Banks for looking after the sound and projection; Gateshead CC for the use of their Print Light Box; Whickham PC for the use of their print stands; our sponsors PermaJet and all raffle prize donators.

Appendix IV

Report from the Representative to The Photographic Alliance of Great Britain (PAGB) PAGB Executive Meeting London 1st and 2nd February 2014

- 1. In response to requests from Federations and clubs guidance has been drafted on Children and Young Persons attending clubs and the production of Safety Policies in accordance with the Health and Safety at Work etc Act. It is anticipated that the guidance will be issued following the PAGB AGM in April.
- 2. Due to a continuing healthy financial balance it was agreed that Federation subscriptions should remain unchanged for 2015 at £34-75, this is expected to be agreed at the April AGM. The financial position will also allow enable the PAGB to continue the £500 support grant for Federations hosting PAGB events. As with last year the Alliance will subsidise ticket costs to Print and PDI Championships by 50%.
- 3. This year's Inter Club Print Championship will be held at Edge Hill University on the 25th October instead of at Connah's Quay. The University facilities are a great improvement with tiered lecture hall seating and the location should make the event more accessible.
- 4. One addition to the list of Judges accredited for PAGB competitions was announced; Brian Swinyard DPAGB ARPS EFIAP/b from the Midland Counties.
 - Two Judges have also been added to the AV list; Howard and Suzanne Gregory DPAGB ARPS from the LCPU
- 5. The revision of the PAGB constitution is progressing with the ambition of producing a final draft during 2014. As part of this process it was identified that Federations must ensure that member clubs are only affiliated to the PAGB through one Federation. Problems have arisen with clubs having dual affiliation, in contradiction of the Alliance Constitution, especially where entries to Inter Federation competitions are involved. Similarly this can involve two Federations paying for a club and its insurance when only one should.
- 6. Draft rules for Inter-Federation Competitions have been produced following consultation with Federations last year. The uploading software is currently being tested, initially by several members of the PAGB Executive prior to testing by Federation Competition Officers during February.
- 7. Lengthy discussion took place regarding the definition of Virtual Camera Clubs and their relationship to both the Alliance and Federations. Agreement was reached based on the definition of a "club" issued by the PAGB's insurers as follows.

"A camera club, photographic society, photographic club or photographic group with a published Constitution and published programme of events, united by a common interest in photography, meeting in person for mutual co-

operation, education, entertainment or competition solely from a physical location within Great Britain, Northern Ireland, the Channel Islands or the Isle of Man"

This definition will be incorporated in the Alliance Constitution and will be applicable from January 2015. It is advised that Federations adopt this definition now when considering new applications from camera clubs.

- 8. A query was raised by a camera club regarding insurance for semi professional photographers and whether the current policy included this category of photographer. The PAGB insurers have confirmed that their policy is for amateur use only and Gordon Jenkins, the Alliance Insurance Officer, will issue guidance to Federations on this point. One Federation representative quoted a recent case of a club member who had camera equipment stolen from his car whilst on holiday. His domestic policy insurer refused to payout on the basis that they discovered from the claimant's website that he was selling prints of his pictures and they considered this to be commercial photography which wasn't covered on his household policy.
- 9. Insurance issues proved to be a hot topic and there was a good deal of discussion about the level of cover for judges and lecturers visiting clubs and using their own equipment. Clarification is being sought on this through the Insurers.
- 10. Guidance has been drafted for Awards in Photographic Merit for AV's and following discussion at the meeting will be revised and issued shortly.
- 11. Of particular relevance for the NCPF was the circulation of a draft timetable for the hosting of the combined Inter Federation Print and PDI Competition. This draft identified that the Northern Counties was scheduled for 2017, I raised concerns about this as we are scheduled to host the Awards for Photographic Merit on the 23rd and 24th April 2016. Following discussion it was agreed that further thought would be given to the hosting of the Inter Federation competition after 2016. The options being either to host it at a central location or look to Federations to volunteer to host the event. Members of this Executive are also asked to consider if they wish to host an Awards Workshop prior to April 2016 to encourage NCPF entries. The event would have to take place soon however as the waiting list for applicants for 2016 will fill very rapidly.
- 12. The PAGB is archiving all of its records at Birmingham Central Library and as part of this process a number of Federations and clubs have added their material to the archive. There exists the potential for other clubs/Federations to do likewise. This would have the advantage of all material being safely held under controlled conditions.
