14/05/04 Correspondence. A comment had been received about publicity for the Spectacular which raised wider issues related to competition awareness and conditions. 14/05/07 Executive and Sub Committee Reports 14/05/07-1 Competitions Organisers Report

The Federation's print entry and PDI's have been sent to the PAGB Inter-federation competition.

Arrangements for the use of Hexham Torch Centre for the presentation event are in hand.

Following issues raised about the Club Championships, Club Secretaries will be continue to informed in the usual way regarding the notification of competitions. (See also Min14/05/04 above)

Noted that software issues were causing concern. Further enquires of Phil Stapleton to be actioned by the Competition Secretary.

Agreed that the judging dates for the Club Championships and the Annuals is to be agreed and set by the Competitions Subcommittee. Dates will be announced at the next meeting. **Appendix II**

14/05/07 -2 NCPF International Salon

Competition information was now on line with only a small number of entries to date. More publicity was planned. Mounted prints could be entered provide they were given/sent to JB and post/return arrangements could be agreed.

14/05/07 -3 Events

Lack of member support was an issue and more prints were required for the Beamish event. Club Secretaries had been contacted. 6 sections were planned for the Presentation evening.

14/05/07 - 4 PAGB Representatives Report

Noted that the PAGB had adopted the PFA/NSA Nature and Wildlife definition.

14/05/07 -5 Northern Focus

Publication will be soon. Much concern about the lack of a hard copy prompted the suggestion of using a publication pattern similar to that of the Scottish PAGB. **Action John Smith.**

14/05/07 -6 Judges Sub Committee

Arrangements were confirmed for the hosting a PAGB Awards workshop on Saturday 19th October 2014 at Clara Vale Community Centre, commencing at 10am. The workshop will be led by Rod Whelans and other members of the PAGB Awards Team. Delegates will be given the opportunity to have an initial panel of work assessed.

The cost of the event will be £5-00 to include a buffet lunch and refreshments.

- **14/05/09- 1 Exhibition Venue** JB identified the Peoples Theatre, Newcastle as avenue that could accommodate and exhibition of 70 mounted prints for a one month period. Competition organisers report May 2014.

I have sent our Federations print entry to the PAGB Inter-federation competition and Cliff has sent the PDI,s.

I have contacted the Hexham Torch Centre and asked them to send a contract for the room hire to Peter Yearnshire for him to sign and for him to send a cheque. To date I have not heard from Peter though I have e-mailed and phoned him.

The competition Subcommittee met on the 23rd of this month and I have replied to Howard Wilson regarding the issues raised regarding the Club Championships, my reply is attached. Most of the Issues raised at the meeting concerned problems for Cliff and John and I leave it to them to report. It was decided that club Secretaries are informed in the usual way regarding the notification of competitions. Some clubs are claiming that they had not been informed however since the majority of clubs are fully aware of the dates this can only lead us to believe that a number of club secretaries are not doing their jobs correctly for whatever reasons.

Regarding the projection of PDI,s at the Club Championships a screen will be used in future, regarding the viewing of prints we propose to change nothing, it is paramount that the judges have the best view possible.

All clubs who choose to enter the Annuals must complete their entry fully, a number of clubs are not submitting a disk of PDI's with their print entry, we propose that if they do not complete their entry in full they will not be judged.

I am at present investigating a new system of entering the competition that should eradicate these problems; I will report my finding at a future date.

It was also agreed that the judging dates for the Club Championships and the Annuals is agreed and set by the Competitions Subcommittee since these are the people who will be running the events and not the Judges subcommittee who will of course select the judges. If this acceptable the date's will be announced at the next meeting.
