#### 19/01/08 **Any Other Business**

Jim Welsh then asked how we would go about acquiring prints from Joe Grabham and Ken Henderson. Dave suggested speaking to the President of Durham PS and Washington CC. Jane Black said she would speak to Ken's daughter to see if she could have some of his earlier portrait prints.

Jane said that Tynemouth had acquired new club rooms at North Shields and the International will still be held there. She then said that they have agreed to store the equipment they hold for the N.C.P.F. After discussion it was agreed that Joseph would contact Howard Wilson to discuss this.

Joseph then asked if anyone had a set of keys for the Community Centre. Margaret said that she had but there should be a second set. After a short discussion she said that Peter may have them. She will speak to him and find out.

At this point, due to the nature of the next item on the Agenda,	Pax Garabedian and Richard Speirs were asked if
they would leave the room.	

Joseph then referred to the updated version of the Executive Committee Rule Book and the ruling for Awards for Meritorious Service. He then said he had received nominations for Pax and Richard to be considered for the Roll of Honour. After reading through both nominations he asked those present to vote by a show of hands. They were both accepted unanimously.

#### Competition Officers Report Jan 15th 2019

#### **Presentation**

The Presentation took place at Clara Vale as planned on Sunday 25<sup>th</sup> November 2018; The attendance was very disappointing with a total of 29 members attending. Last year we had 37 members attend the event.

When you consider the work and organisation that is involved to put on such an event it is very disappointing for the members of the subcommittee to see their hard work ignored.

I don't know where we go from here, but I feel the problem needs to be addressed ASAP as it seems pointless to proceed with this event as members don't seem to be interested in its current form.

#### **Club Championship**

Entries are still being received for the club championship with the final date for acceptance being January 27<sup>th</sup> 2019.

#### **Annuals**

The Annuals are due to take place on Fri 5<sup>th</sup> & Sat 6<sup>TH</sup> April 2019.

Unfortunately we have a major problem. Both Cliff and myself have been forced to resign due medical problems, Cliff due to Severe Arthritis and myself having a second knee replacement. I have spoken to Gerry and he is willing to stand in for Cliff so that's the digital competition taken care of. Everything is in place regarding the judges with the exception of booking the accommodation at the Premier Inn. This information has been circulated to members of the subcommittee and in Northern Focus but to date we have not received any volunteers.

I think the main reason for the lack of volunteers is due to the transporting and storage of 30+ boxes of prints for 3months which is a daunting task.

One way to consider overcoming the problem would be to use the same principle for the prints as we do in the Club Championship, have clubs deliver their entries on say the evening before (ie Thursday) and then collect them on the Saturday evening after the event. This would mean a total commitment from submitting clubs but if they wish the competition to continue it may be their only choice.

We will need to inform Roy Lambeth of the PAGB as to who is taking over the position of Competitions Officer.

I will be available to help with the club championship, but once this competition is over I will resign from the NCPF Exec Committee.

I would like to thank everyone for their help and assistance during the time I have served on the Exec Committee, and a special thanks to the members of the Comps subcommittee because without them nothing would have been possible.

# REPORT OF THE REPRESENTATIVE TO THE PHOTOGRAPHIC ALLIANCE OF GREAT BRITAIN TO NCPF EXECUTIVE COMMITTEE 15th January 2019

- 1. The PAGB held the second Master's of Print Exhibition in London at the beginning of December. The event was well supported by many of the PAGB sponsors such as Epson, Fotospeed, Permajet, Canon and Sony and received many favourable reviews from the public visitors during its run at the Burt Gallery in London. A decision regarding a repeat for 2019 has yet to be made
- 2. The Awards for Photographic Merit November event, hosted by YPU, in the magnificent Pontefract Town Hall was a great success due to the hard work of the YPU organising team. Two members of an NCPF club, Penrith and District, were successful with David Connell gaining his CPAGB and Jo Knight her DPAGB a year after she achieved her CPAGB. Jo was also successful in getting one of her prints accepted and displayed in the Masters of Print Exhibition.
- 3. The next Awards adjudication will be held in North Wales in April and entries are virtually full at the time of writing. The November event will be taking place in Watford and spaces for CPAGB are already starting to fill up although there are still plenty of spaces for both DPAGB and MPAGB.
- 4. There has been a reasonable response for the Awards in Audio Visual this year, numbers are not yet sufficient to run the event and the deadline for entries has been extended to the end of tis month. Should sufficient entries be received the event will take place over the weekend of 18<sup>th</sup> and 19th May at Wilmslow Guild.
- 5. The next meeting of the PAGB Executive will be held on the weekend of the 2<sup>nd</sup> and 3<sup>rd</sup> February. Barring any unforeseen circumstances I will be attending on behalf of the NCPF.
- 6. I have decided that 2019 will be my last year to act as the Federation's representative to the PAGB and I have forewarned the Alliance Executive of my intention to resign from that role as from the 2020 AGM in April of next year. I will be more than willing to assist any new Representative from the NCPF as much as I am able.

The Northern Area Projected Image Knockout Competition between six of the Northern Area Clubs was held on Sunday 18<sup>th</sup> November 2018. Amble Photographic Group hosted the event and the judging panel were Alan Porrett, Gerry Adcock and David Ord.

After the first round, Morpeth, Blyth and Cambois were eliminated from the Knockout Trophy but would later compete against each other for the Digital Plate. Alnwick, Amble and Ashington competed for the Trophy resulting in Amble and Ashington tying for 1<sup>st</sup> place with 172 points and Alnwick coming third with 170 points. A count back took place between Amble and Ashington to determine the winner of the Trophy. Ashington had one 15 point score and Amble had one 15 point score and two 14 point scores, resulting in Amble being declared the winners of the Trophy. The battle for the Plate between Morpeth, Blyth and Cambois was won by Morpeth with 166 points. Cambois came second with 164 points and Blyth was third with 147 points.
