The last meeting of the Competition sub-committee was held on 16 December with the next meeting due on 27 January.

The storage of equipment at Tynemouth was discussed at the Executive meeting on 17 December and it was agreed that a small team will review the equipment that is stored and dispose of redundant equipment.

The laptop that was purchased for use at future presentations is held by John Fare.

Since the last meeting the rules and entry sheets for the Club Championships have been issued. The entry sheets have been modified so that they are in a similar format to the Annual Competitions entry forms. Phillip Dove has also modified the spreadsheets used to assess the entries so that where PDI entries don't comply with the resolution and format rules this is automatically flagged rather than manually checking each entry.

The availability of the equipment for the Club Championships was confirmed and responsibility for bringing the equipment was agreed. There was a potential problem with the number of helpers on the day but this has now been resolved. The judges have been contacted to confirm their availability for the Championships.

A reminder to clubs about the competition will be sent out shortly.

The use of a cloud based storage solution was discussed at the last Executive committee meeting and it was agreed that a small group will look at implementing Microsoft 365 as the preferred option. Dependent on the option chosen up to 6 users could each have 1TB of Microsoft One Cloud storage space. Users can share folders with other users providing they have a Microsoft account.

Club Championship Print and PDI Entries Officer Report January 2025

The first of the entries for the 2025 Club Championships have arrived with me. The first three pdi entries and one print entry have been put through the checking process. All have been correctly named, but for a few typos which were identified and corrected, and added to the system which will generate the score sheets and the folder of images ready for projection. The size checking has, in the case of one club, identified a misunderstanding of the rules about sizing images with some portrait and square images arriving at 1600px tall. It was believed that a square image of 1600 width was correctly sized at 1600 tall. At the request of the comp sec who submitted them, I have resized them. I suspect that this misunderstanding will not be exclusive to this club.

So far all is going well, which puts us well ahead of the game compared with last year as we needed to wait until the closing date for entries before creating the rest of the system. It was only then that we knew how many entries we had. The new system is dynamic and as new entries are received, the sheets adjust to suit the content.

A small piece of software that I have recently acquired is capable of looking at a folder of images and extracting all of the EXIF data from the file. Some of this will be useful in identifying duplicate images. This data (or as much of it as deemed useful), along with a thumbnail of the image can be stored in an Excel File. This can be saved onto a Microsoft OneDrive system without taking up anything like as much space as a folder of images, making an archive of competition entries quite straight forward. It should also allay any fears that images of a usable size could, as a result of being stored on a 'cloud system' fall into the wrong hands.

NORTHERN AREA KNOCKOUT COMPETITION

The Northern Area Knockout Competition was initially held by Wooler CC on Sunday 24th November 2024. The three judges were Glen Lawson, Rob Butler, and Geoff Green.

After Round 1 however, it all went pear shaped, and after nearly three hours waiting for Round 2 to commence the competition was abandoned and rescheduled for Sunday 12th January 2025.

Despite the original complaints from the Club members who attended, there was an acceptable turn out for the re-run. This commenced with Round 2 and ran without a hitch.

Round 2 was the Trophy Semi Final between Amble, Alnwick, Cambois and Morpeth with the two highest scoring clubs, Amble with 167 points and Morpeth with 162 points going through to compete for the Trophy. Amble won with 170 points to Morpeth's 162. Ashington, Blyth and Wooler competed for the Plate. Blyth won with 163 points, Ashington came 2nd with 162 points and Wooler came 3rd with 157 points.

The Trophy was collected by a member of Amble and the Plate was collected by Jim. Wooler CC provided tea and cake during the break which was very nice. Thanks were given to the three judges and to the attending club members for making the journey twice. An enjoyable afternoon was had by all in the end.
